Mount Cotton Road and Redland Bay Road Planning

Community update

February 2023

The Department of Transport and Main Roads (TMR) is undertaking planning for Mount Cotton Road, Redland Bay Road and the Redland Sub-Arterial Road, including the Double Jump Road, Ney Road and Taylor Road intersections.

As part of the planning process, we are asking the community who live, work and travel through this area to share their transport priorities and concerns, including any safety and congestion issues.

The community will be informed of the outcomes once the consultation process is completed and all feedback has been collated.

Funding

The Queensland Government has committed \$3.7 million to undertake this planning to identify options to address safety concerns, congestion and other issues within the study area.

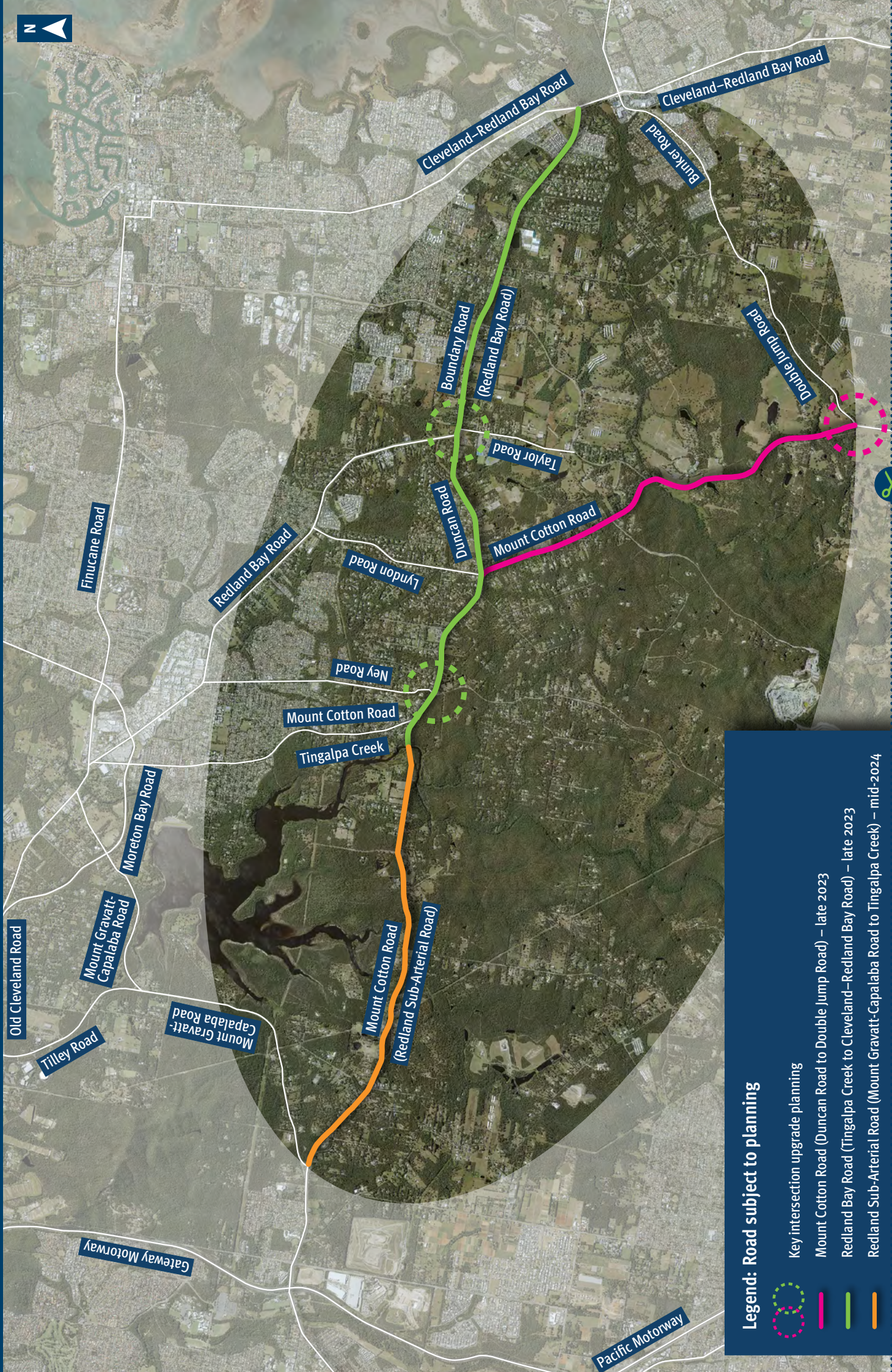
